

Elliot Kaye - Chairman CPSC

Elliot F. Kaye was sworn in as the 10th Chairman of the U.S. Consumer Product Safety Commission (CPSC) on July 30, 2014. President Barack Obama nominated Mr. Kaye on March 31, 2014, and he was confirmed by the U.S. Senate on July 28, 2014, to a term that expires in October 2020. Chairman Kaye has identified three major areas of focus that will advance his collaborative leadership approach:

- •CPSC will further harness the experience and expertise of agency staff and safety experts in the private sector to achieve more safety advancements for the American public;
- •CPSC will continue to prioritize and work to accelerate culture change around brain safety in youth sports; and, •CPSC will be committed to strengthening its line of defense at U.S. ports to keep dangerous imports out of the

WATER SAFETY AND DROWNING PREVENTION LEGISLATION

Nancy Baker - Parent Advocate

Thursday, April 13 - 2:00pm - 3:00pm



Nancy Baker is the mother of 7-year old Virginia Graeme Baker who drowned when she became entrapped on the drain of a hot tub. Since Graeme's death on June 15, 2002, Nancy has become a national parent advocate to ensure that similar deaths can be prevented. She advocates to promote the use of safety devices that not only prevent entrapment in pools and spas, but also for safety devices and practices that prevent traditional forms of drowning. Nancy is also a national spokeswoman, an artist, art teacher and the mother of four daughters. Graeme's grandfather, former Secretary of State James A. Baker, actively supported these efforts to advocate for drowning prevention. Nancy responded to a personal tragedy and turned it into a triumph. Nancy's keynote will review the trials, tribulations and ultimate success surrounding the passage of the first federal legislation addressing pool and spa safety. That legislation— The Virginia Graeme Baker Pool & Spa Safety Act — named after Nancy's daughter, changed the way public pools and spas are built and maintained in this country. Nancy will also, most certainly, inspire attendees to continue the work they do every day, often without the appropriate recognition, to protect children from both drowning and entrapment. She knows, first hand, that it is possible to make a difference!
